This year, a total of 13 students from East Holmes and West Holmes will be participating in the Tri-County ESC Pre-Apprenticeship Program. Students are completing the program in support of earning their high school diploma. Students are earning work-based learning hours, completing resumes, participating in mock-interviews, taking tours of businesses, being mentored and listening to career speakers.

The Tri-County ESC BAC plans to expand the program and offer additional pathways, potentially in the areas of education and information technology.

### Learning Targets

Session 1	<p><b>Objective:</b> Students will gain a clearer understanding of the career exploration process and how their own skills and interests match up to a chosen career path. Students will explore and identify the relationship of personal abilities, goals, skills, interests, and motivation to academic achievement and career success.</p> <p><b>Outcome:</b> Students will reflect on their unique strengths, skills, and career aspirations and will be able to list at least one career path they are interested in exploring further. Students will identify a personal, educational, and/or future career goal.</p>
Session 2	<p><b>Objective:</b> Students will explore a variety of education pathways, career clusters, and industry sectors. Students will learn about the variety of traditional and non-traditional occupations and related education and training options. Students will associate their future education and work lives with subject matters learned in school and understand in general terms what qualifies people for that work.</p> <p><b>Outcome:</b> Students will participate in hands-on career exploration in a career of their interest using Virtual Reality headsets.</p>
Session 3	<p><b>Objective:</b> Students will understand that behaviors such as punctuality, courtesy, proper dress and language, and hard work are essential to academic and career success. Students will learn how the changing workplace requires lifelong learning, flexibility, and the acquisition of new employment skills. Students will gain knowledge about employability skills such as individual initiative, teamwork, problem-solving, organization, and communication.</p> <p><b>Outcome:</b> Students will identify what soft-skills/employability skills are and be able to provide at least three examples of using these skills and how it applies to them personally.</p>
Session 4	<p><b>Objective:</b> Students will learn about critical thinking skills to make informed, ethical, and socially responsible decisions regarding wants, needs, and aspirations. Students will gain an understanding of how to apply problem-solving and decision-making skills to make safe and healthy choices. Students will build awareness of the world of work and gain an understanding of the importance and value of work and jobs to society. Students will understand the impact of career and education choices on their lives and learn about the value of ethical standards and behaviors in the future education and in the workplace.</p> <p><b>Outcome:</b> Students will better understand how their own personal growth and personal success impact their future career and satisfaction. Students will be able to identify the effect of career choices on quality of life.</p>
Session 5	<p><b>Objective:</b> Students will understand how to utilize local resources to research education and career plans. Students will learn the skills involved in locating, using, and interpreting a variety of career and educational resources locally. Students will learn about transitioning to the workforce, and hear advice regarding early careers from Young Professionals (40 and under) in Wayne County. Students will have the opportunity to ask questions of Young Professionals.</p> <p><b>Outcome:</b> Students will hear from Community Leaders about the resources available to them in the area. Students will learn from Young Professionals. Students will practice networking and collaboration skills through interactions with Community Leaders and Young Professionals in Wayne County.</p>

One of the challenges that the BAC has experienced in regard to the goal of establishing Pre-Apprenticeship programs has to do with the Hospitality and Tourism Pathway. Unfortunately, there are not many Registered Apprenticeship Programs in the Hospitality and Tourism Pathway in the State of Ohio. Because of this, the options for our Pre-Apprenticeship Program to partner with a Sponsoring Registered Apprenticeship were limited this year. The BAC and Pre-Apprenticeship Planning Group continues to explore options for expanding the sponsorship relationships within the area of Hospitality and Tourism Pathways.
